Privacy Statement Manifest Arbeidsrecht

Manifest Arbeidsrecht respects your personal information and ensures that personal information provided to Manifest Arbeidsrecht or otherwise obtained is kept confidential. In accordance with the General Data Protection Regulation (hereinafter "AVG"), measures have been taken to protect the security of your personal data, which are set out in this Privacy Statement. Personal data

Period of retention

Manifest Arbeidsrecht retains personal data processed no longer than necessary for the aforementioned purposes of data processing or as required by laws and regulations.

Sharing of personal data

Your personal data will be shared:

- to comply with a legal obligation, such as to regulators or other authorities;
- when this is relevant for the (legal) provision of services, such as to counterparties, courts, government agencies;
- when processed by suppliers of your personal data to whom we outsource services.

Information is shared only on the bases stated in this privacy statement and for the purposes named herein. Where third parties process your personal data, they are responsible for ensuring that it is processed properly. Manifest Arbeidsrecht enters into a processing agreement with these suppliers that complies with the requirements set out in the AVG.

Protection of your personal data

Manifest Arbeidsrecht is committed to keeping your personal data as secure as possible and protecting it from loss, data leakage or any form of unlawful processing. To this end, up to date technical and organizational measures have been taken and are constantly updated. In the event Manifest Arbeidsrecht uses the services of third parties, a processor's agreement will set out arrangements for adequate security measures.
